Sunday, September 10, 2 - 4 pm

Join Katie Menne for active, collaborative learning focused on a creative new approach and justifications for why planning and facilitation must start and finish with accessibility and inclusion. OMA responds to disappointing Oregon legislature session

The board of the Oregon Museums Association would like to express our disappointment in the outcomes of the 2023 legislative session. In January, we sent a letter asking the House Committee on Economic Development and Small Business to support HB 2459. This bill would have provided an additional \$50 million in aid to arts and culture organizations still recovering from the longest pandemic shutdowns in the country.

The outcome: just \$5.6 million for "independent venues," for which most museums will not qualify. We need this funding. Economists working with the Cultural Advocacy Coalition estimate that recovery for arts and culture organizations will take 5 years; much longer than other businesses.

We stand with the Cultural Advocacy Coalition of Oregon in expressing our disappointment for HB 2498, which was a request for \$200 million in lottery bonds to be allocated to the Oregon Cultural Trust. We are dismayed by the denial of an increase in Oregon Arts Commission (OAC) funding.

Report connects cultural heritage conservation to social justice, equity, and environmental action



The Foundation for Advancement in Conservation and the National Endowment for the Humanities have released Held in Trust: Transforming

Cultural Heritage Conservation for a More Resilient Future. I his report articulates a vision of a vibrant and resilient future for conservation grounded in social justice, equity, and environmental action, in which conservators and communities work together to preserve the rich cultural heritage of the US.

"Historically, the conservation and preservation field has excluded non-dominant perspectives and identities. The demographics of the field (predominantly white, female, and upper-middle-class) serves to illustrate some of the challenges in entering the field: limited regional access and daunting prerequisites for graduate degree programs, lack of recognition of alternate training and education pathways, and a reliance on free labor through internships or through employment opportunities that do not reflect cost of living.

"The challenges facing preservation and conservation of cultural heritage today reflect those facing our families, communities, nation, and the world. This report characterizes trends, identifies challenges, and articulates a vision for the future, in which conservation and preservation have everything they need to thrive. You will see actionable steps that can be taken by cultural institutions, communities, practitioners, funders, and supporting organizations. We offer these, and the forward-thinking narratives which frame them, as a source of inspiration as we work to preserve our nation's rich cultural legacy for the benefit of communities now and in the future."

MentorCorps is a trained group of volunteers with professional experience in collections care, emergency management, and non-profit management. They can assist with projects that are challenging the expertise of the staff or volunteers at your organization. This can include guidance in project management or planning, grant reviews, collections assessments, policy development, or simply prioritization of work if folks do not know where to start. With experienced mentors that are geographically and technically diverse, there are very few projects that MentorCorps cannot assist with in some way.

Applications are due August 15, 2023. Organizations will be assigned a mentor for a 10-month period to have time to assess and prioritize projects.
