Prescribing culture to build health and well-being

The Mass Cultural Council started CultureRx, a pilot program focused on advancing the role of culture as a protective factor for the health of everyone in Massachusetts. The initiative brought together partners in public health, social services, and the cultural sector to make the case for cultural experiences as an essential investment in well-being.

One health clinic gave referrals (social prescriptions) to museums, theaters and cultural venues for specific health reasons such as social isolation, depression, and hypertension. The pilot was a success (even during a global pandemic) and will advance statewide next year.

Dutch government to explore unconditional return of looted objects

The Dutch government has promised to create a new policy on restitution, after an official report urged the unconditional return of looted museum objects to their countries of origin.

According to the report, "The recognition of injustice and the willingness to rectify it as far as possible should be the key principles of the policy on colonial collections in Dutch museums. The Netherlands must therefore be willing to return unconditionally any cultural objects looted in former Dutch colonies if the source country so requests."
