Museums and health

"Research has shown that art and cultural expression, as well as narks and

green space, can have strong impacts on health outcomes at an individual and population level. Arts and culture can mend collective trauma, improve social isolation and exclusion, address mental health, and reduce certain chronic diseases. The presence of parks and green space also has a demonstrated impact on mental health, social isolation and exclusion, and chronic disease." (from *Creative Placemaking: Using Arts and Parks to Improve Community Health*)

Five Oaks Museum launches guest curator program

The guest curator program at the Five Oaks Museum (formerly Washington County Museum) de-centers the authoritative voice of major exhibits, creating a platform for culturally embedded storytelling.

Molly Alloy and Nathanael Andreini, co-directors, explain, "we are shifting the museum's authority by prioritizing community-driven storytelling; we see the museum as a platform for descendant communities to shape their own histories and cultures. We also understand 'truth' as a moving target and seek to expose museum visitors to these complexities in a multitude of ways... through exhibits, curriculum, and events."

Guest curators have creative control over the design, content, and texts of a major exhibit filling the museum's 1,200 square foot exhibit hall. Five Oaks Museum will host an information session for those interested on **February 4**, **2020**, **1-3** pm.
